

IRC clustering tool: a network intelligence tool

To strengthen EU-AU research coordination and knowledge brokerage under the FNSSA partnership, CEA-FIRST has launched a Clustering Tool that maps and analyzes groups of R&I projects and initiatives by theme, geography, and institutions. Building on the LEAP4FNSSA approach, it supports the structuring of the International Research Consortium (IRC) by organizing information on projects, stakeholders, and expertise into meaningful "clusters."

The tool also underpins IRC operationalization and links with complementary platforms such as the FNSSA project database to power knowledge extraction, and partnerships.


The following dashboards will be accessible to the IRC members:

- 3. FNSSA Initiatives: scan programmes and initiatives across FNSSA



The gender and youth strategy for the AU-EU FNSSA partnership stresses that transformation of food systems cannot occur without women and youth as central actors. Building on the CEA-FIRST Gender and Youth Strategy and Action Plan, inputs from YPARD, CORAF and partners call for embedding gender-transformative and youth-responsive approaches directly into the FNSSA Roadmap 2027-2037. This includes making gender and youth inclusion a requirement for project eligibility, ensuring Monitoring, Evaluation and Learning (MEL) systems track not just participation but also leadership roles, and prioritizing inclusive capacity building—aligned with the AU target of at least 50% women in PhD training.

In the IRC Functional Working Groups Strategy, the recommendations go further by requiring women and youth to actively shape decisions and innovation processes. Proposals include at least 30% representation of women and youth in governance, gender- and youth-sensitive MEL indicators with annual reporting dashboards, and institutionalized training in digital, financial, and leadership skills. Communication outputs should also highlight inclusive success stories. Together, these measures shift the FNSSA agenda from rhetorical commitment to concrete, measurable inclusion, ensuring women and youth are co-owners of Africa-Europe food systems transformation.


